Driver Education Program

Dear Parents,

The purpose of this letter is twofold, first to find out if there is enough interest to offer Driver Education at Hoosic Valley Central(on weekdays), or Cambridge Central(on Weekends) again this Spring, and second to inform you of your son's/daughter's benefits and responsibilities in taking Driver Education. In order to make Driver Education cost effective, we need a minimum of 16 students to enroll in the program.

The goal of this program is to equip your son/daughter with the fundamental knowledge, correct operational habits, essential skills, and the proper attitude for survival on our highways. From successful completion of this program, your son/daughter will be issued a Student Certificate of Completion (MV-285). This certificate will allow them to drive at night after they convert their class DJ license to a class D license, at age 17. Without the MV-285 certificate, they cannot drive, without a parent or guardian, between the hours of 9:00 PM and 5:00 AM until they are 18 (See a copy of the New York State Driver's Manual for other restrictions on the DJ License). The certificate also makes possible a reduction in the cost of your added insurance premium, when applicable.

Students must be 16 years of age by the start of the course to be eligible for the Spring Session.

If offered, the program will run from **Feb. 1st through May 24th**. The classroom session will be held from 3:05 pm - 4:30 pm on Wednesdays (Hoosic Valley) or 10:40 am – 12:10 am on Weekends (Cambridge) with car sessions offered the other days after school and before and after class on Weekends. **The students will select time slots for car sessions on a first come first serve basis.** The students are allowed to miss two classroom and car sessions and can travel to Cambridge on Weekends to make up classes.

The cost of the program will depend on the number of students that sign up for the course. In the past the cost has been between \$410.00 and \$430.00. **A \$210.00 deposit is required by Jan. 30th.** Checks should be made payable to Hoosic Valley Central Schools or Cambridge Central Schools depending on which school you prefer.

The remaining payment will be due on March 8th, assuming that there is enough interest in the program. If there is not enough interest in the program, the \$210.00 deposit checks will not be cashed and they will be returned to you.

If you are interested in the program, please fill out the information on the last page and return it no **later than Jan. 30th**. Please include the deposit of \$210.00. You may mail this form to the school, (Atten: Tim Ryan) or turn the application and checks into me in Room 211 at the high school.
